



OFFICIAL RULES

1. NO PURCHASE NECESSARY TO ENTER OR WIN.

2. **ELIGIBILITY:** Open to owners of auto repair service facilities who are (a) residents of the 50 United States, D.C. and Canada, (b) 18 years of age and older as of June 27, 2023, and (c) whose service facilities are WIX Filters customers (new or current).
